- iv. the Contract is not intended to be regulated by and the Customer will not assert or otherwise rely on any right to the benefit of any protection and / or any remedies that might otherwise be available to it under the Consumer Credit Act 1974;
- v. all of the details and information contained or disclosed in this Vehicle Hire Order which are material to or relevant the Customer are true, complete and accurate in all respects;
